MPKI enables secure communication with partners and mobile workers, offers complete control over security policies, and reduces PKI implementation complexity for enterprises.



Certificate Lifecycle Management

ePromise

- Signing the student sponsorship agreement documents and confirmation slip.
- Students (including government employees), guarantors, and JPA officers.
- After the student agrees to the sponsorship/loan offer, both the student and the guarantor must apply for a digital certificate from MSCTG. Online identity verification (eKYC) is done through the MyTrust ID application before the digital certificate is issued.

Then, the student, guarantor, and JPA officer will sign the documents digitally through the JPA portal.

- Apply for STA Permit

Furthermore, all meeting minutes concerning the approval must be transmitted electronically.

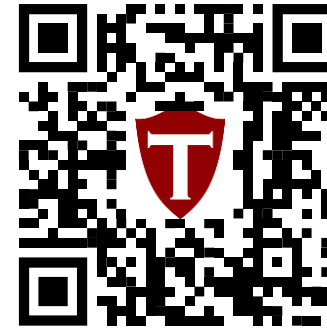
