

SOFTWARE LICENSE AGREEMENT

BY CLICKING ON THE "ACCEPT" BUTTON, DOWNLOADING THE SOFTWARE OR OPENING THE PACKAGE, YOU ARE CONSENTING TO BE BOUND BY AND ARE BECOMING A PARTY TO THIS AGREEMENT. IF YOU DO NOT AGREE TO ALL OF THE TERMS OF THIS AGREEMENT, DO NOT DOWNLOAD THE SOFTWARE, OR CLICK THE "DO NOT ACCEPT" BUTTON, AND, IF APPLICABLE, RETURN THIS PRODUCT TO MSC TRUSTGATE.COM.

This Software License Agreement (the "Agreement") is made between you, the end user, and MSC Trustgate.com, ("MSC Trustgate.com").

- 1. Grant of License. MSC Trustgate.com grants to you a non-exclusive, non-transferable license to use its proprietary software modules (the "Software") on computers or network servers under your control that are used in connection with obtaining the MSC Trustgate.com service, in return for your payment of the applicable fees. You are expressly prohibited from sublicensing, selling, renting, leasing or otherwise distributing copies of the Software. You may not use the Software for any use prohibited by law.
- **2. Intellectual Property Protection.** The Software, including its operation, code, architecture and implementation, as well as the look and feel of the Software is the valuable intellectual property of MSC Trustgate.com and/or Symantec. The Software is protected by United States and Malaysia copyright laws and international treaty provisions. This Agreement does not give you any intellectual property rights in the Software. You agree not to modify, translate, disassemble, decompile, reverse engineer, create derivative works of, or make any other attempt by any means to discover or obtain the source code for the Software.
- **3. Limited Warranty.** MSC Trustgate.com warrants that the Software will perform substantially in accordance with MSC Trustgate.com's published specifications for the Software for a period of ninety (90) days from the date you acquire the Software. Your exclusive remedy, and MSC Trustgate.com's entire liability in tort, contract or otherwise, for any breach of this warranty shall be, in MSC Trustgate.com's sole discretion: (i) to repair or replace the Software or (ii) to refund the associated Managed PKI service fee. Any replacement Software will be warranted for the remainder of the original warranty period or thirty (30) days, whichever is longer.

This is a limited warranty and is the only warranty made by MSC Trustgate.com. MSC Trustgate.com makes no other warranty, expressed, implied or statutory, including without limitation, any implied warranty of merchantability, fitness for a particular purpose, or non-infringement of third-party rights. If implied warranties may not be disclaimed under applicable law, then any implied warranties are limited in duration to the above limited warranty period. This Agreement shall be governed by the laws of Malaysia applicable to contracts executed and performed entirely in Malaysia.
